In General:

- USDF 2007 tests and CT 2006 tests
- Judged in accordance with USEF rules with exception of dress. Must be neat in appearance (breeches, shirt/polo, helmet, coat, clean half-chaps with nice boots acceptable). NO full chaps, braiding/banding optional, callers allowed.
- Judges decision is final.
- Awards: Ribbons 1st through 6th in each class/test. High Score Ribbon for Champion of each full division. Series End High Percentage Average Award to be awarded to the horse & rider combo with the highest percent average at the same level for at least two shows of the series (awarded at last show of the series).
- Dressage Arena: sand outdoor
- Warm-up Arena: sand/rubber indoor
- Riders can enter multiple tests &/or classes with the same &/or different horses. Horses may be shared by multiple riders.

Group Classes:

- Dressage Suitability: Judged on suitability to become a dressage horse. Classes open to horses any age who have not competed above first level
- Dressage Equitation: W-T open to riders who have not shown above training level. W-T-C open to all riders. **Judge may ask for class specific tests, i.e. trot a 20 meter circle for W/T or sitting trot no stirrups for W/T/C.
