

SHORT COURSE EVENTING COMBINED TEST & DRESSAGE SHOW SERIES at Campbell Springs Farm

(Short Course consists of a judged dressage test and a cross country course with a few stadium jumps included in the cross country course)

JULY 18, AUGUST 16, OCTOBER 25 & NOVEMBER 21

Levels:

- Tad Poles:** Dressage Intro Test B, 6-8 poles on the ground efforts. Great for introducing a horse or rider to eventing.
- Elementary:** Dressage Intro Test B, 8-10 jumping efforts, mostly logs, up to 2'.
- Advanced Elementary:** Dressage Beginner Novice Test B, 10-12 jumping efforts up to 2'3". Great course to move up to before moving up to BN, small solid cross country obstacles, some coups and "houses", as well as logs.
- Beginner Novice:** Dressage Beginner Novice Test B, 10-12 jumping efforts up to 2'7", coups, houses, logs, bank.
- Novice:** Dressage Novice Test B, 12-14 jumping efforts up to 2'11", coups, houses, logs, bank, small ditch.

All Short Course Divisions are \$55.00

Dressage Test of Choice (USDF Intro – 4th Level & USEA Tests) \$25.00 per test

Closing Dates: Monday before each show. \$15.00 late fee will be charged after closing date.

- Refunds **ONLY** due to horse ailments, and **ONLY** if spot can be filled by Wednesday before the event. **Participant must submit letter from veterinarian stating that horse is unable to compete. Refund will be less \$10 office fee.**
- If there is inclement weather and the cross country course is deemed treacherous, the Competition will be a changed to a Combined Test (Dressage Test & Stadium Jumping).
- **Competition Cancellation** – Refund less \$10 office fee. **No entries will be transferred to a later show date.**
- **Dress is casual, tall boots or paddock boots with half chaps allowed, protective vest is mandatory on the cross country course. Helmets mandatory.**
- **Cross country course will be closed Thursday before each show - Cross Country schooling – After show ONLY!**
- **\$50 invoice for un-returned pinnys, \$35 returned check fee**
- **NO unleashed dogs**
- **Current Negative Coggins required with entry form.**
- Ride times will be posted on www.CampbellSpringsFarm.com the Friday morning before the show date.
- USEF and USEA rules will apply to all phases of the competition.
