Dressage Tests

2007 USDF Intro A or Intro B & 2007 USEF Training - First Level

20M x 60M ring

- 1) Dressage show entries: \$20.00 per test. Same special fees for dressage as CT.
- 2) Combined Test dressage to start tentatively at 9:00am (times to be posted). Stadium tentative start: 11am.
- 3) Awards: ribbons to 6th place in Dressage and CT. In addition to individual placing, we will be offering a combined training team challenge for teams of 3 or 4 riders.
- 4) Teams can be made up of juniors and seniors and can be competitors from any levels of the combined test competition. Best 3 scores count. For teams of only 3 riders, eliminated riders will be given a score of 100 penalty points and the team will not be eliminated from the challenge. Please indicate team information on entry.
- 5) **Ride times: available at www.CVACTA.org on the Thursday before the show.**
- 6) Dress: Casual but neat attire with dress or paddock boots/half chaps, breeches and ASTM hard hats. Medical armbands should be worn during show jumping. Use of a body protective vest while mounted is strongly recommended.
- 7) Readers are allowed in dressage only classes; readers not permitted in CT dressage classes.

DIRECTIONS: Take I-64 to Exit 167 - Oilville. If coming from east, turn right at the end of the ramp onto Route 617. If coming from west of Oilville, take left at end of ramp. Go 1/2 mile, then turn left at the second sign for Route 617 (Oilville Rd – then becomes Pinhook Rd). Go 2.8 miles to the stop sign. Turn left onto Vontay Road. Go 1/2 mile to No Worries Farm on right - 19290 Vontay Road. Follow directions to park.
